1. The agreement between the Exhibitor and the Miami County Fair Board shall be effective, upon signature of the person(s) reserving the booth space. \_\_\_\_\_ (initial)
2. Exhibitor is renting space from the Miami County Fair Board during the Miami County Fair and Rodeo July 18- July 26, 2026, located at the Miami County Fair Grounds. \_\_\_\_\_ (initial)

6. Food Vendors will need to provide a list of food and drinks they would like to sell. The Miami County Fair Board limits same food competition between vendors, and vendor may be asked to remove item/discontinue sale if said item was not

7. Exhibitor agrees to provide all materials for the construction of their booth. Exhibitors will not construct anything permanent, and will leave the grounds in the same condition as when it was received. ☒(initial)
  8. ALL BOOTH RENT MUST BE PAID IN FULL PRIOR TO THE MIAMI COUNTY FAIR AND RODEO SIGN-UP DEADLINE (June 30, 2026). EXHIBITORS WILL NOT BE ALLOWED TO SET THEIR BOOTHS/TRAILERS UNTIL FULL PAYMENT HAS BEEN RECEIVED.

  9. There will be no refund of rent, unless the fair is not held, or the Fair Board cannot provide booth space. In this case, the exhibitor's rent will be refunded, and the vendor will be released from the agreement. (initial)
  10. Outdoor booth spaces are 10' x 10'. If additional space is needed the vendor will be charged \$5 per 1' x 10' addition. This includes trailer hitches, unattached signs, etc. NO EXCEPTIONS. \_\_\_\_\_(initial) **If you're using a trailer, we need EXACT dimensions of your trailer/set up.
